NCPD Board approves statement on "Futile Care."



The Governance Board of the National Catholic Partnership on Disability recently issued a statement explaining its position on "futile care." The term refers to the practice of physicians withholding or withdrawing life-support they consider non-beneficial. The practice received national attention last year when a Catholic hospital in Texas sought to remove a respirator from a dying infant, against his mother's objections, on the grounds that the procedure was causing substantial pain and that the hospital's first duty was to the infant. The incident revealed that many states permit physicians to withhold or withdraw life-sustaining treatment they consider medically inappropriate contrary to their patients' wishes.

Although recognizing that most physicians act with compassion and competence, the Statement acknowledges the reality that physicians are not immune from resting the decision to withhold or withdraw life-support on their patients' quality of life rather than on the quality of the treatment involved. This is especially true today given the emphasis on containing costs. Since such decisions would impact disabled people disproportionately, NCPD, with its mission to implement the Bishops' 1978 Pastoral Statement on people with disabilities, decided to provide an analysis of "futile care" in light of Catholic moral teaching.



In Silent Prayer: A History of Ministry with the Deaf Community in the Archdiocese of Philadelphia

Written by Father Anthony Russo, who has devoted himself to the deaf community for over forty years, *In Silent Prayer* traces the history of this special ministry in the Roman Catholic Archdiocese of Philadelphia. Through insightful text, as well as historical documents and photographs, Father Russo not only tells the story of the great men and women who have provided this important service, but also looks forward to the coming years and considers how this service can be further shaped and improved. Specific examples of how to establish an effective ministry are included along with a discussion of the ideas and attitudes necessary to effect change and progress in ministry today.



Father Anthony Russo, C.Ss.R., grew up in Clifton, New Jersey, and has experienced some degree of hearing difficulty throughout his life. In 1955, he received a Bachelor of Science degree from the Virginia Military Institute in Lexington, along with a commission in the US Army. Ordained by Cardinal Spellman of New York in 1965, Father Russo was sent in 1967 to the Archdiocese of Philadelphia, where he has dedicated his life to working with and for the deaf.

Accessible Ambo Designs and Ideas

If you are looking for a company from which to purchase a wheelchair accessible or universally accessible ambo you might have trouble finding a company that produces them. We have some unique responses to the need for an accessible ambo that we have collected from dioceses around the U.S. We will feature examples of four different accessible ambos and one altar lift. Each one was built to order and is not “mass produced” (no pun intended).

Fr. Michael Eswein uses a lift that his father built for him that is situated behind the altar and raises him in his chair to a “standing height”. At right is a picture of Fr. Mike at an altar in St. Louis.



The Diocese of Toledo is represented at left in a photo they shared of Renee at an accessible ambo at St. Ann’s. Marsha Rivas is the diocesan director there.

The Cathedral of Our Lady of the Angels in the Archdiocese of Los Angeles has an accessible ambo. A picture can be found at their website: <http://www.olacathedral.org/> then go to Art then Ambo for a picture and the story of the accessible ambo and information about the artist who designed it.

St. Pius X Church in Cedar Rapids, IA in the Archdiocese of Dubuque has what is called a “nestled” ambo for wheelchair users or short people. A short duplicate of the ambo is nestled under the standard sized ambo and can be pulled out for use when wanted. It is the perfect height for people using wheelchairs. The parish is unique in that most all of the liturgical furnishings were made by parishioners, and that is the case with this ambo. Steve is pictured at left using the nestled ambo.

Andy Hasley at ahasley@aol.com; 319-651-1019 is a member of the Access Manual Committee member mentioned earlier. Andy has designed an ambo built by Hasley Construction, Inc., that is height adjustable for anyone who uses it, from child to adult, wheelchair user to an

ambulatory person.
