The set comes with up to six archive binders, depending upon the print size, so that the priest or deacon can exchange the parts of the Sacramentary that are not needed in the formal altar binder, with the current liturgical season pages. This allows the Sacramentary used at the altar to be a size that is manageable for their liturgical needs.

It will be good for you to note that during the Fall General Assembly the bishops approved in both English and Spanish the Order for the "Blessing of a Child in the Womb" for use in the dioceses of the United States. The "Blessing of a Child in the Womb Within Mass and Outside Mass" upon recognitio by the Congregation on Divine Worship and the Sacraments in Rome, will be included in future editions of the Book of Blessings when the text is revised. The "Blessing of Parents before Childbirth" that is currently in the Book of Blessings is distinctly

different from this latest approved blessing because its focus is on the parents and not on the child in utero, itself.

As a parent of a child with a genetically transmittable disability, I can say with assurance what it would have meant to have this formal blessing during my at-risk pregnancies for my children who followed Larry's birth. But can't you imagine the meaningfulness of having such a blessing during any pregnancy? The information about the "Blessing for a Child in the Womb" could be especially encouraging information for you to pass on to families who approach you after finding out that their child in utero was found to have issues that indicate potential problems prior to or following birth.

# NCPD Ethics Committee Seeks Prayer for the Protection of Unborn Babies Diagnosed with Disabilities

Abortion is often justified because the baby in the mother's womb has been diagnosed (sometimes mistakenly) as having a disabling condition. Parents often feel coerced by their doctors and others to abort a child who may be born with any number of conditions. It is reported that between 80% and 90% of children with a diagnosis of Down syndrome are aborted. We affirm the value and dignity of every person and turn to our mother Mary for protection of these unborn babies by praying daily the following:

#### Memorare

Remember, O most gracious Virgin Mary, that never was it known that anyone who fled to thy protection, implored thy help, or sought Thine intercession was left unaided. Inspired by this confidence, I fly unto thee, O Virgin of virgins, my mother; to thee do I come, before thee I stand, sinful and sorrowful. O Mother of the Word Incarnate, despise not my petitions, but in thy mercy hear and answer me. Amen.

#### Hail, Holy Queen

Hail, Holy Queen, Mother of Mercy, our Life, our Sweetness, and our Hope. To Thee do we cry, poor banished children of Eve. To Thee do we send up our sighs mourning and weeping in this valley of tears. Turn then, most gracious Advocate, Thine Eyes of Mercy toward us, and after this our exile show unto us the Blessed Fruit of thy Womb, Jesus. O clement, O loving, O sweet Virgin Mary. Pray for us O Holy Mother of God that we may be made worthy of the promises of Christ. Amen.

Mary, Immaculate, Protector and Patroness of our country, be with us always.

**30th Anniversary Teaching Moments**: We encourage all of you to remember the Pastoral Statement of US Catholic Bishops on Persons with Disabilities (full text at <a href="www.ncpd.org">www.ncpd.org</a>) in all the work you do this upcoming year. The anniversary (Nov. 16, 2008 - Nov. 15, 2009) is a great "hook" to teach the components of sacramental welcome and liturgical inclusion, and as a way to bring new partners to your work. USE EVERYTHING to teach the Pastoral... mention it during every meeting, and make it a part of your everyday work, such as your signature line on emails or on your voice message. Here's some tag line language:

"Celebrating the 30th Anniversary of the Bishops' Pastoral Statement, proclaiming we are one flock under the care of a single Shepherd."

AND you can reference this statement from Cardinals Justin Rigali and Daniel DiNardo, who wrote:

We join the **National Catholic Partnership on Disability** in calling on all people of good will to find new pathways, develop new partnerships, and bring new vitality to this ministry, ever mindful that we are one flock under the care of a single shepherd.

Our Holy Father called us to draw near to "Christ Our Hope" during his recent visit to the United States. Throughout this 30th anniversary year, let us "Live Christ Our Hope," as we honor the gifts that people with disabilities bring to their faith communities, and rededicate ourselves to ensuring their meaningful participation in all aspects of the Church and society.


## **Diocesan/Partner News**

#### I Believe Too

One of our Mental Illness Council Co-Chairs, Deacon Tom Lambert of Chicago, has a daughter who has taken a stand that is a beautiful witness in the D.C. area. Tom's daughter, JoEllen Murphy, initiated an "I Believe Too" campaign to counteract bus ads in D.C. that say "Why Believe in God...Just be good for goodness' sake," initiated in November by the American Humanist Association (AHA). JoEllen explained her motivations on the "I Believe Too" web site at <a href="http://www.ibelievetoo.org">http://www.ibelievetoo.org</a>: "After a friend forwarded me an article about the AHA ad campaign, I thought, 'Enough!' I am so tired of God and religion being attacked that I decided to

start a counter ad campaign."

A Catholic News Agency article of Dec. 3 noted, "Following a secular humanist ad campaign in Washington D.C. which questioned religious belief, an initiative called "I Believe Too" has been launched to "counteract" the secular campaign with "a positive, upbeat ad that identifies God as mankind's 'true and loving creator' (CNA)."



### **NCCL Topics**

The National Conference on Catechetical Leadership is a valued partner of NCPD and many of you are members of NCCL as are we. The NCCL Conference planning Committee is still accepting nominations for persons to conduct Roundtables, Poster Postings and Hot Topics events at the 73<sup>rd</sup> NCCL Annual Meeting and Conference to be held in April. We encourage you to download and complete one of the forms found on their website <a href="www.nccl.org">www.nccl.org</a>, and recommend topics and people who can present on issues related to inclusion or access for children and youth with disabilities in catechetical ministry if you would like to see this topic covered. You might recommend yourself if you are already planning to attend, and bring a Poster Posting on something you have achieved in ministry to display and make available for all to see during that important conference. It is a great "awareness" opportunity to share the message of inclusion.

### **Green Bay Model for Awareness Activities**

The Diocese of Green Bay Retreat for Adults with Disability was recently featured by Sam Lucero, Editor of the Compass, in the Diocesan newspaper. He spent almost the entire day at the retreat and wrote a wonderful article that you will find at the link below. Mr. Lucero also presents a slide show of activities during the day at this link that is narrated by adults with disabilities whom he interviewed.

Deacon Bill Burkel, a member of Prince of Peace Parish in Bellevue, directs the retreats. The retreat team also consists of Mary Eckert, activities director, and Donna Sommers, music coordinator. Eckert attends Prince of Peace Parish in Bellevue and Sommers is administrative assistant for the diocesan Department of Stewardship and Pastoral Services. Numerous volunteers serve as co-retreatants, leading small-group activities and assisting retreatants who have special needs.

Susan Perrault, a former diocesan director and current parish minister and NCPD Board member who was a co-retreatant, shared this link with us. The slide show provides a wonderful model that we all can use, featuring interviews that let people with disabilities tell their own

stories and share their faith in their own words.

Note: Once the web page is up, don't start the slide show for about a minute to allow adequate time for the slide show to fully load. Then it will not stop for "buffering" during your viewing.

#### **Diocese of Richmond**

**November 15 Parish Advocate Day** Diocesan Disability Director, Nita Grignol, hosted a first annual Parish Advocate Conference with a variety of workshops, networking opportunities and presentations for her 88 parish advocates serving in 72 parishes. NCPD Executive Director Janice Benton gave a keynote and I provided a closing prayer as we enjoyed the day with all. Nita held her meeting at two sites through the use of video conferencing technology the diocese has recently installed. It was her maiden voyage with the technology but the 15 people gathered at a distant site seemed very happy to have the opportunity to participate through that means.

One Parish Advocate Can Make a Big Difference Our day in Richmond was filled with conversations and lots of listening to very creative parish advocates. I would like to feature one of those parish advocates, Karen Jackson, to encourage anyone who is thinking of implementing this approach to consider the possible benefits.

Nita is a new, energetic and creative diocesan disability director, who works part-time in a oneperson office. She reports directly to the bishop but realized that she would need a lot of help and a structure to initiate the kind of impact she hoped to generate for disability ministry in the diocese. This is where her parish advocates come in. This is only one story of 88 that could be told of Nita's parish advocates.

On the "job" for this past year, Karen Jackson makes herself available to consult on a variety of inclusion/access questions and needs that come to her attention, as do most parish advocates. She is a parent of a child with disability herself and was sensitive to the need of a faith support group for parents of children with disabilities at her parish, Blessed Sacrament Catholic Church in Norfolk, and began one called the Living in Holland parent support group. This support group meets monthly.

Karen also created a network for faith inclusion in the Tidewater area. Called the Faith Inclusion Network (FIN) of South Hampton Roads, it is an interdenominational and service provider network group that promotes awareness of and provides support for the inclusion of people with disabilities and their families into faith communities in the South Hampton Roads area. This creative idea that Karen envisioned she now directs. FIN has 41 members, 12 of which are representatives of various service agencies in the area and the rest are religious leaders, staff and some parent leaders. FIN is hosting its first conference on Saturday, May 30, 2009 (contact Karen Jackson if you would like to receive the brochure at <a href="mailto:dacapomusic@cox.net">dacapomusic@cox.net</a>).

### **Diocese of Metuchen**

The Diocese of Metuchen is holding a *Symposium to Foster Awareness for People with Disabilities* on March 7, 2009, at the St. John Neumann Center, 146 Metlars Lane, Piscataway,

NJ 08854. It is being sponsored by the Offices for Catechesis and Respect for Life. This daylong symposium is held for all those who have special needs, those who minister with them, and parents/family members. Participants will be able to choose from diverse workshops that promote awareness, develop programs and fine-tune what is already being offered in parishes. The day will include keynote speaker Steven McDonald, a NYPD Detective Lieutenant who was paralyzed by three bullets in 1986 and now travels the world inspiring audiences with his powerfully moving message on nonviolence and forgiveness. The day will also provide a choice of workshops, lunch and prayer. ### **Postcard Campaign for Life**

We received a maillist alert from the USCCB Department of Justice, Peace and Human Development on November 25 that we want to share with you. In the email from John Carr, Executive Director, he states

"The USCCB Pro-Life Committee has authorized a major postcard campaign to communicate our opposition to any legislation that would expand abortion, especially the Freedom of Choice Act. The goal would be to collect postcards in parishes and deliver them to members of Congress. ... At this time we are looking at a January 2009 effort in the parishes, which will be preceded by educational outreach to Catholics and the public at large on the seriousness of the threat to pro-life policies. ... This is an important time to demonstrate our commitment to the dignity of human life from conception to natural death. We urge you to contact your pro-life colleagues and do everything you can to cooperate with them on the postcard campaign."

### **Legislation**

SSA Class Action Suit

The American Council of the Blind filed a class action suit against the Social Security Administration (SSA) asking for additional notice options for individuals with a visual impairment. A federal court has certified a class composed of applicants, beneficiaries and representative payees with visual impairments that substantially limit their ability to see so that they require communications from SSA to be in an accessible format in order to participate in the Social Security or SSI programs. The class action does not include any claims for money damages.

SSA will display a poster of the class action notice in large print in field offices across the

country from November 14, 2008 through January 16, 2009. At the same time, there will also be links to the notice on <a href="www.socialsecurity.gov">www.socialsecurity.gov</a> and at <a href="www.segurosocial.gov/espanol">www.segurosocial.gov/espanol</a> and a toll-free number will be available for people to call to hear a recording of the notice in English or Spanish. The toll-free number is 1-866-940-0765.
